September 2021 was our last newsletter. However, in March 2022, we emailed a memo on letterhead to members and mailed the memo to 19 AICs with updated information.



TDNFTC's current projects

TESTIMONIES – With teams forming and our website up and running, TDNFTC would like to add a page to our website with testimonies from current and former AICs. Either written or videoed, these would include information on what an AIC and their family/friends went through when they were charged with a Measure 11 conviction. In these testimonial videos AICs and their families can share the trials and tribulations they had to adapt to and the challenges they had to endure. We want to help educate our communities of what AICs and their families went through upon their release and what has helped them succeed versus what has not. If you would like to find out more information, know of someone who would be willing to be interviewed or would like to be interviewed yourself, please contact us. These testimonies would help us educate the public and would also mean a lot to others that are searching for information or just trying to succeed.

2023 BILL – TDNFTC will be submitting a new bill with more guidelines to try and get it to the floor for vote. Our bill will be (again) for AICs to be able to earn good time (sentence reduction). We will modify it for First Time Offenders and make sure it is retroactive.

SPONSORS – We are asking for companies and individuals to support TDNFTC by donating. Depending on the amount donated annually, you will achieve different levels: Gold (over \$500), Silver (\$250-\$499), Bronze (\$100-\$249), or Family (\$25-\$99). Each level will be tax deductible. Visitation

Visitation is open and all visits must be scheduled via ICSolutions prior to arriving at the facility.

All visitors must ensure they are on the AIC's approved visitors list before scheduling an in-person visit. While the online system allows for scheduling regardless of visitor status, the visit will be denied at the institution if the visitor is not approved. Check with your incarcerated loved one to ensure your visiting status is up to date. You can email the visiting application form to the Visitor Services Unit or it fax to (503) 373-1173. You can also mail the form to Visiting Services Unit, 3723 Fairview Industrial Dr. Suite 200, Salem, OR 97302.

As a reminder, cloth masks and gaiters are approved face coverings; however, they must be double layered. Single layer gaiters may be worn as a face covering as long as they are folded over to create two layers of fabric over the nose and mouth.
