## **Greetings from our Co-Founder**

My apologies for going silent with our newsletters. It takes time and volunteers to write and distribute a newsletter. It cost approximately one dollar per AIC to print and mail a newsletter. We have over a thousand AIC's that would like our newsletter. Good news, we now have funding to start our quarterly newsletters back up.

TDNFTC has been honored to receive a grant from the Yarg Foundation to further our goals in getting the word out on Measure 11 here in Oregon by sending out our Newsletters.

TDNFTC has achieved non-profit status – 501c3 status. Any donations to TDNFTC are now tax deductible and we can now do fund raisers.

AIC's that want to improve, need incentives to have a positive future. Incentives play a big part of that role. Without incentives what is there to look forward to? How do AICs show they want to improve? Without incentives are there goals? Without incentives and goals how can an AIC better themselves upon release? Being able to "earn" sentence reduction/good time gives an AICs the incentive to work toward a positive goal.

#### Bills

There are several bills in congress this year pertaining to AICs. You are intitled to contact your Senator and Representative and let them know your opinion on each bill.

SB 270 – Authorizes AICs to enroll in academic program at any community college in state, any distance learning academic program or any other higher education academic program that adult in custody applies for and is accepted into, provided that enrollment in academic program is consistent with administrative rules and regulations adopted by DOC.

SB 320 – Provides that person sentenced to mandatory minimum sentence under ballot Measure 11 (1994), for crime other than murder, who has not been previously sentenced under measure is eligible for reduction in sentence for appropriate institutional behavior and participation in certain programming unless otherwise ordered by court for substantial and compelling reasons.

SB 321 – Creates process by which person convicted or found guilty except for insanity as result of nonunanimous jury verdict may file petition for post-conviction relief within one year of effective date of Act.

SB 467 - Establishes mandatory minimum sentence of 48 months' imprisonment for assault committed by correctional facility inmate against corrections officer.

SB 520 - Establishes Medical Release Advisory Committee within State Board of Parole and Post-Prison Supervision. Specifies qualifications of members of committee. Establishes procedures by which AIC may apply for early medical release from custody and standards by which committee recommends release. Establishes cap on number of applications per month committee may consider until January 1, 2026.

SB 579 - Allows persons convicted of felony to register to vote, update voter registration and vote in elections while incarcerated. Specifies that person's residence is where person resided prior to incarceration.

#### Visitation

All visitors must ensure they are on the AIC's approved visitors list before scheduling an in-person visit. While the online system allows for scheduling regardless of visitor status, the visit will be denied at the institution if the visitor is not approved. Check with your incarcerated loved one to ensure your visiting status is up to date. You can email the visiting application form to the Visitor Services Unit or it fax to (503) 373-1173. You can also mail the form to Visiting Services Unit, 3723 Fairview Industrial Dr. Suite 200, Salem, OR 97302.

As a reminder, cloth masks and gaiters are approved face coverings; however, they must be double layered. Single layer gaiters may be worn as a face covering as long as they are folded over to create two layers of fabric over the nose and mouth. For visiting rules see,
